- Ability to evaluate, plan and direct process improvement projects and benchmark activities for clinical and non-clinical departments.

Tasks:

- Supports developments and improvements of the quality management system and informs and instructs users;
- Ensures required policy and procedure documents are developed, reviewed and implemented within the organization;
- Supports hospital accreditation projects by providing coaching to staff as needed and leading project work groups;
- Supports auditing programs by developing audit tools, conducting tracers, reporting on audit findings, and monitoring corrective actions;
- Functions as the first contact for internal parties regarding issues on quality and safety;
- Supports the collection of data for quality and patient safety performance indicators.
